A nonprofit organization is a group organized for any purpose except profit, including social welfare, civic improvement, and pleasure or recreation.

[Do Non-Profit Organizations Have to File Tax Returns?](#)

The Non-Profit Information Return (form T1044), due no later than six months after the end of your fiscal year, is often overlooked by NPOs. CRA can assess penalties of \$25 per day for failure to file this form. The minimum penalty is \$100, up to a maximum of \$2,500, for each failure to file.

RC11: Do non-profit organizations and charities have to file income tax returns to Revenue Canada? Yes. Even though most non-profit organizations are exempt from income tax, the organization must still complete an income tax return each year to report to Revenue Canada.

Canada Revenue Agency (CRA) filing requirements for Non-Profit Organizations (NPO s) T2 Corporate Income Tax Return All corporations including non-profit organizations, - have to file a T2 return for every tax year, even if there is no tax payable. You can file the rebate application for your qualifying non-profit organization as a whole or, if your qualifying non-profit organization has branches or divisions, you can apply to have the branches or divisions file separate GST/HST returns and rebate applications. To do so, each branch or division has to be identifiable by either its location or the nature of its activities.
