The five (5) day notice to quit is a form to be used, where applicable, to notify a tenant that they are in non-compliance with their lease due to a violation.

[A Landlord's Five Day Notice: The Who, What, When, and How](#)

A 5 day notice means that the tenant is entitled to 5 full days to make payment in full of the past due rent. That means if you serve the notice on the 15th of the month, the tenant gets the 16th, 17th, 18th, 19th, and until midnight on the 20th; you cannot file the lawsuit until the 21st. Don't make the mistake of filing the complaint on the 5th day. If you do, your lawsuit will be

Every Chicago landlord needs to be able to pull a blank eviction notice, in Chicago 5 day notice, out of the desk drawer at any time. In Illinois, a landlord may not file an eviction process unless the tenant fails to pay the outstanding rent within 5 days after service of a written demand for payment.

If the five-day deadline has passed and the tenant has not disputed the notice or paid the overdue rent or utilities, the landlord can apply for an Order of Possession and a Monetary Order using the direct request process.
