3-Day Notice to Quit (Non-Payment) This form is used if the tenant has failed to pay the rent when it is due. The tenant will have three (3) days to respond to the notice before you can file a petition with the court.

The New York ten (10) day notice to quit, also known as a Notice to Cure, is a document which is used to begin the eviction process when a tenant has committed one or more lease violations.
